

# Public Sector Transfer Network (PSTN) List of Participants

This document was last updated on: 09/02/2024

#### Purpose

This document provides a list of organisations designated as "approved organisations" for the purposes of <u>Section 4</u> of the <u>Superannuation and Pensions Act</u>, <u>1963</u>. This version has been updated to take account of bodies designated through <u>S.I. No. 455/2023</u>.

#### Background

The rules governing transfer of service in pre-existing public service pension schemes are primarily set out in <u>Department of Finance Letter to Personnel Officers 24 April 1979</u> '*Draft Transfer Scheme*' and <u>Letter to Personnel Officers 30 January 1981</u> '*Transfer of Service for Superannuation Purposes*'. The transfer scheme has its origins in <u>Section 4</u> of the <u>Superannuation and Pensions Act 1963</u>, which, in summary, provides that a person who is currently employed in a pensionable capacity in an "approved organisation", may transfer pensionable service from one approved organisation to another, subject to the criteria set out in the transfer scheme rules. Collectively, these approved organisations make up what is known as the 'Public Sector Transfer Network' (PSTN).

#### **Important Points**

- The PSTN facilitates the transfer of pensionable service in "pre-existing" public service pension schemes only. Information on transfers under the Single Scheme can be found in <u>Circular 15/2019</u>.
- The Local Government Transfer Network falls under the remit of the Department of Housing, Local Government and Heritage. Queries relating to the LGTN should therefore be directed to that Department.
- Defined Contribution schemes do not operate on the basis of "pensionable service" and are therefore excluded from the PSTN. As such, bodies listed are members in respect of their Defined Benefit pre-existing pension schemes only.
- The system of contribution to apply between two member bodies whose contribution systems differ is agreed when a transfer first occurs between those bodies. This is a matter for agreement between those bodies, taking account of each body's funding mechanisms, and DPENDPDR have no role in this process. The agreed system of contribution continues in respect of all transfers between those bodies thereafter.

#### Appendix Joining the PSTN

Membership of the transfer network is voluntary and organisations must apply to join. Under the 1979 letter, bodies wishing to join the network must complete the six questions contained within that letter which then sets out their terms of participation in the transfer scheme. These questions can be summarised as:

- 1) Will the body accept the terms of the transfer scheme?
- 2) What operative date do they wish to operate for Part I&II bodies (Civil Service, An Garda Síochána etc.)?
- 3) Which system of contribution for post-operative date transfers do they wish to adopt for transfers to/from Part I&II bodies?
- 4) Will the body cover pre-operative date transfers?
- 5) Which method of service credit will be used (e.g. year for year)?
- 6) Will the civil service transfer value tables be used?

#### Systems of Contribution

Question 3) of the above six questions asks that a body decide on their preferred system of contribution. The 1979 transfer scheme introduced four different systems of contributions that participating bodies could opt for in respect of transfers to and from that body. The contribution system is set out in paragraph 16 of the 1979 transfer scheme and as such, each system of contribution draws its name from that paragraph. The four systems are:

- 16(a) "Knock-for-Knock",
- 16(b) "1963 Act" contributions,
- 16(c) "Uprated 1963 Act" contributions, and
- 16(d) "Transfer Values".

The system of contribution selected by a body on joining the PSTN applies to transfers to and from the groups covered by Parts I and II of the Scheme, i.e. the civil service, teaching, Garda Síochána and Defence Forces. This is the contribution system listed under "System of Contribution" in the tables in this document. The system of contribution to apply between member bodies whose contribution preferences differ is agreed bilaterally between those bodies when a transfer first arises. The agreed system of contribution then applies thereafter between those bodies.

Detail on the various systems of contribution follows:
